ECKL CONVERGENCES WEBINAR - SOUTHEAST ASIA IN CONTEXT: INTERNATIONAL RELATIONS IN THE NEW NORMAL - AN AMBASSADORIAL DIALOGUE

In the IMF's latest World Economic Outlook, projections for 2020 growth in Asian countries range from a 6.7% contraction for Thailand to growth of 1.2% for China, 1.9% for India and 2.7% for Vietnam, the highest in emerging Asia. The Philippines and Indonesia are also expected to stay positive, growing 0.6% and 0.5%, respectively, while Malaysia is projected to contract 1.7%. Much of Asia's near-term future depends on the economic recovery of key trading partners.

There is also uncertainty due to countries in the region being at different stages of the pandemic and to the continuing danger of secondary waves of infections. Hence the extreme uncertainty around the global growth forecast. Many countries face a multi-layered crisis comprising a health shock, domestic economic disruptions, plummeting external demand, capital flow reversals and a collapse in commodity prices. The economic fallout depends on factors that interact in ways that are hard to predict.

Southeast Asia will play a key role in global growth. However this will be contingent on international trade remaining resilient, given the reliance of Southeast Asia on trade. With that in mind, two key factors to Southeast Asia's continued success are 1) International Trade and 2) global exchanges of information. Examples of the latter include international research partnerships, international education and technology transfers.
